# Neighborhood Watch Assistance

• Jasiah Neff from the City of San Diego, program manager for the Environmental Services Department, was our guest. He discussed working with the mayor in a "sting" operation for the homeless in our Del Cerro Little League Field area.

Jasiah presented an overview of his experience. He is now heading Clean San Diego as well as many other programs related to this. Jasiah reviewed the Homeless Abatement updates; Get it done; Neighborhood Policing; Canyon abatements; etc. Jasiah specifically reviewed Del Cerro's Chaparral Canyon issues and ownership and suggested contacting our council person. He had some suggestions for Adobe Falls, Canyon — possible solutions / actions:

Add Signage "Under Surveillance"

Add Cameras, etc. and Prosecute Trespassers

Schedule a Curbside Cleanup. Free service and info is located online

- Jim Liston is in charge of the Linfield-Regis Neighborhood Watch Program, a newly rekindled Neighborhood Watch that could be our example for the watches through out the Del Cerro area. Jim reviewed their neighborhood watch history. They are starting again with a meet and greet to get to know each other to establish comfort and confidence. Start small
